Yujo Lemon Lot User Agreement

1. All vehicle registration requirements must be current prior to Lemon Lot registration approval.
2. All Lemon Lot permit(s) will expire on the date listed on the registration form. **If no waiting list exists**, your vehicle may be registered for an additional month as long as all vehicle requirements are current. **If a waiting list exists**, your registration request will be treated as a new customer request and you will be placed on the waiting list.
3. All Yujo Lemon Lot parking spots that are vacant for more than 48 hours will be considered abandoned and registration and parking spot will be forfeited. **Non-refundable**.
4. The Yujo Community Center, 374th Force Support Squadron, and their personnel will not be liable for items stolen from vehicles or damage(s) to vehicle while parked in the Yujo POV Lemon Lot.
5. The Yujo POV Lemon Lot registration form must be displayed in the windshield of your vehicle while parked in the Lemon Lot. **NOTE:** Lemon Lot parking spots range from 1-47.
6. Long term parking spots will be based on space availability and maybe limited to specific parking spots, that can be reserved for a 3 month period. **No refunds will be issued if a vehicle is sold prior to registration expiration date.**
7. Customers may elect to register vehicle(s) for both the Yujo Lemon Lot and the Virtual Lemon Lot at a discounted rate, registration for both services must occur on the same date. **No refunds will be issued if vehicle is sold prior to registration expiration date.**
8. The Yujo Lemon Lot and/or Yujo Virtual Lemon Lot **may not be** used for personal gain or in association of a personal or private business, IAW AFI 34-101 and YABI 31-116. Any violations may result in a citation and removal by Security Forces.
9. Government of Japan, IHA or MLC local national employees, may use the Yujo Lemon Lot or Virtual Lemon Lot to sell their vehicle(s) on a Space Available basis.
10. Yujo Lemon Lot customers must notify the Yujo Community Center staff timely when your vehicle is sold.
